BEKKER HIGH SCHOOL BUS TRANSPORT: RULES AND REGULATIONS

1. **No learner will be allowed on the bus without a ticket or a token** – tickets are not transferable.
2. Make sure your child is on time at the bus stop. Our drivers work according to a schedule and cannot wait if you are late.
3. Normal school rules apply at all pick-up and drop-off points.
4. Learners will be liable for the cost of any damage they cause to our buses.
5. No objects may be thrown out of bus windows.
6. Learners have to keep our buses clean, take your litter with you.
7. No foul language is allowed on the buses.
8. Any learner that makes racist remarks will no longer be allowed to make use of bus transport and disciplinary action will be taken against such a learner.
9. All learners have to respect the bus driver and each other.
10. The bus driver may not be distracted by any learner while driving.
11. Learners have to respect the prefect.
12. No fighting or bullying will be allowed on the buses.
13. **No learner is allowed to give cash to the bus driver or teacher on the bus.**
14. Learners can buy tickets from Monday till Thursday at the bus ticket office, before school and during breaks. **Tickets are not available for purchase on Fridays.**

✘▶ Please note: A seat fee of R200.00 is payable to reserve your child's seat, no student will be allowed on the bus if the seat fee is not paid.

C. UNDERTAKING BY PARENT / GUARDIAN – TERMS AND CONDITIONS

I undertake to:

- Pay a seat fee of R200.00 and send the proof of payment with the COMPLETED contract to the school to ensure the learner's seat on the bus for 2021 is reserved.
- Buy a monthly ticket as indicated in the contract. If my child does not use the bus on some Fridays or Sundays, I will forfeit the fees **OR** buy trips and use them as needed.
- Pay for the cost of any damages caused by my child.
- Give a **calendar month** notice when the learner stops using the bus during the school year.
- Be held responsible for the fees for one month if I don't give a month's notice.
- Pay the first month in cash if I make use of a debit order as the debit order will only be deducted from the end of January.
- Make sure my debit order is deducted from my account if applicable.

Furthermore, I understand that:

- It is my responsibility to ensure that my child knows and understands the bus transport rules and regulations as indicated above.
- **No Parent/Guardian is allowed to give cash to the bus driver or a teacher.**
- EFT payments must be done no later than Wednesday to ensure that the payment reflects on the bank statement by Friday 7:00.
- **SHOULD PAYMENTS NOT REFLECT ON THE STATEMENT BY FRIDAY MORNING AT 7:00, THE TICKET OR TOKENS WILL NOT BE ISSUED!**
- The learner’s seat on the bus is reserved for the full year, as soon as the seat fee is paid.
- Neither the Governing Body nor the bus staff can be held responsible for any loss of or damage to any personal belongings of my child.
- It is my responsibility to ensure the reference on my payment is correct and I agree to fax or e-mail my proof of payment to the school.
- ***The applicant will be held responsible for payment of bus fees.***
- ***Any SEAT FEE payable with acceptance of this application is non-refundable.***
- The Governing Body reserves the right to review arrangements regarding the monthly ticket/tokens at any time as they see fit.
- **BUS FEES MAY BE ADJUSTED AT ANY TIME DURING THE YEAR DUE TO PRICE INCREASES. SHOULD THE FEE BE INCREASED, THE PARENT HAVE THE RIGHT TO CANCEL THIS AGREEMENT IN WRITING WITH ONE MONTHS’ NOTICE FROM THE DATE OF ANNOUNCEMENT OF THE NEW FEE.**
